**ORDER**

**WHEREAS** the appeal of Doon Valley Institute of Education (Doon Valley Trust), Karnal, Haryana dated 08/02/2010 is against the Order No. F.NRC/NCTE/HR - 409/20096/15591 dated 25/01/2010 of the Northern Regional Committee, withdrawing recognition for conducting B.Ed course on the grounds "1) CLU is not submitted. 2) Building Completion Certificate is not submitted. 3) Land is not in the name of the institution".

**AND WHEREAS** the Correspondent, Doon Valley Institute of Education (Doon Valley Trust) (hereinafter referred to as the appellant), preferred an appeal dated 09/02/2010 to the National Council for Teacher Education, New Delhi (hereinafter referred to as the Council) under Section 18 of the NCTE Act, 1993 against the said Order.

**AND WHEREAS** Shri. Imtiaz Ahmad, Vice-Chairman and Shri. Naresh Kumar, Chairman, Doon Valley Institute of Education (Doon Valley Trust), Karnal, Haryana presented the case of the appellant institution on 16.3.2010. In the appeal and during personal presentation it was submitted that at the stage of grant of recognition to the appellant firstly for 100 seats on 16.8.2004 and thereafter, for a total of 300 seats on 29.9.2006, NCTE had satisfied itself completely as regard the requirements and parameters under the NCTE Act 1993 and Regulations/Guidelines. It was also submitted that the notice dated 12.8.2004 issued by the District Town Planner, Karnal was declared null and void and not binding on the appellant. It was further submitted that the ground regarding non submission of building completion certificate was not tenable inasmuch as land of the appellant and the building constructed thereupon was within the jurisdiction of the Municipal Committee, Karnal and the necessary permission was duly granted by the competent authority and that the land was in the name of the trust which was running the Doon Valley Institution of Education. During the presentation, the representatives of the institution also submitted that no Show Cause Notice was issued to the institution before withdrawal of recognition of the institution.

**AND WHEREAS** the Council noted from the order dated 25.01.2010 of the NRC under reference that the institution had requested for grant of approval for merging Doon Vallley College, Chirao, Karnal alongwith its sanctioned intake of 100 seats with Doon Valley College of Education, outside Jundla Gate. The Council also noted from the file that a number of separate institutions in the same name of Doon Valley Institute of Education were being either run at different places in Karnal or the institution had submitted a number of applications for recognition of teacher education courses inasmuch as six files namely, HR-193, HR-253, HR-254, HR-296, HR-409 and HR-674 were found referred to in a communication issued from the file No. HR- 409 of the NRC. Further, as already stated, no Show Cause Notice was issued to

the institution before withdrawing recognition vide NRC's order dated 25.01.2010, which was not in order. Therefore, the Council was of the view that the case should be remanded back to the NRC for issuing show cause notice to the institution and, thereafter taking, appropriate decision.

**AND WHEREAS** after perusal of documents, memorandum of appeal, affidavit, VT report and after considering oral arguments advanced during the hearing, the Council reached the conclusion that there was adequate ground to remand the case to NRC for issue of show cause notice to the institution and thereafter taking appropriate decision.

**NOW THEREFORE, the Council hereby remands back the case of Doon Valley Institute of Education (Doon Valley Trust), Karnal, Haryana to the NRC, NCTE, for necessary action as indicated above.**
