## PUBLIC NOTICE

The National Council for Teacher Education (NCTE) invites applications for recognition of teacher training courses for the academic session 2011-2012, except the States and UT as indicated in para 2 below. Applications in the prescribed form should be submitted '**ONLINE**' to the concerned Regional Committee alongwith necessary fee and documents as prescribed in the NCTE Regulations, 2009 from **1<sup>st</sup> August, 2010 to 30<sup>th</sup> September, 2010** only.

2. The NCTE, with a view to achieve planned and coordinated development of teacher education system and in order to regulate the growth of teacher education at all levels, has decided, on the basis of statewide study conducted on Demand and Supply of teachers and also in consultation with the State Govts. / UTs, not to accept applications for recognition of teacher training courses including additional intake to the existing recognized courses for the academic session 2011-2012 in the following States/UT for the courses specified against each :
